**Cancellation:** This Agreement cannot be cancelled or modified except in writing by either the Client or WedPhoria. If Client initiates cancellation less than 90 days prior to the event, then the Client is responsible for the total due the day of event. Rescheduling for events canceled due to inclement weather shall be accommodated without penalty whenever possible. Rescheduled events are subject to availability.

**Provisions:** The Client shall ensure that: (1) the facility provides proper electricity; (2) facility is open 1 hour prior to scheduled start time; (3) the facility meets all federal and state safety regulations and has all appropriate music licenses and performance permits where applicable; (4) reasonable steps will be taken to protect WedPhoria's equipment, personnel, music, and crowd control will be provided if warranted; (5) for outdoor performances, shelter will be provided that completely covers and protects WedPhoria's equipment and personnel from adverse weather conditions. Client accepts full responsibility and is liable for any damages, injuries, or delays that occur as a result of failure to comply with these provisions. In the event of circumstances deemed by WedPhoria, equipment, or recordings, then WedPhoria reserves the right to cease performance until such time as Client resolves the threatening situation. WedPhoria further reserves the right to deny any guest access to recordings or equipment. In the unlikely event that WedPhoria's performance is delayed, liability is limited to providing Client with performance time equal to time lacking.
